2. The scrap material is for sale on "AS IS, WHERE IS BASIS" No claim shall be entertained on any account regarding quality/condition of the materials what so ever, once the offer of bidder is accepted during the auction.

On ANNOUNCEMENT for acceptance of the offer of the bidder the bidder will be required to deposit on the spot an amount of Rs.2,000/- as Earnest Money Deposit by way of Demand Draft payable or Pay order in favor of : Accounts Officer, Films Division, Mumbai" The bidder shall be allowed to take out the scrap materials only after depositing the entire amount quoted along with VAT applicable.
4. All the interested bidders are hereby advised to remain present themselves on the date and time mentioned above.
5. All the bidders will have to register their names with the Films Division, Mumbai by 22-3-2013.
6. The stores being auctioned will be available for inspection of the bidders between 11.00 am to 5.00 pm. from 19-3-2013 to 22-3-2013.
7. Highest bidder will have to remove the material at his own cost within 3 days of acceptance of offer & after making full payment, otherwise storage charges shall also be levied @ Rs.100/- per day. If bidder fails to deposit entire amount as per the auction process within 2 days, then their EMD shall be forfeited.
8. Other terms and conditions shall be declared at the spot during the auction.
9. All the bidders have to submit his/her identity ( Pan Card, Voter-I Card) at the time of registration & Auction.
10. No conditional offer shall be entertained.
