**INSTRUCTIONS TO BIDERS:**

1. The bid in respect of item mentioned above should be addressed to The Director General, Films Division, Ministry of Information & Broadcasting Government of India, 24, Dr.G.Deshmukh Marg, Mumbai- 400 026. The Bid should be dropped in drop box kept near the entrance of 1st phase Building, Films Division, 24-Dr.G. Deshmukh Marg, Mumbai-400 026 up to **1.00pm on 19.06.2014 and will be opened at 3.00 p.m.** on the same date in the presence of the bidders or their representative who may be present. The bid received after the due date and time shall not be considered.

2. The bid should be accompanied by Bid Security of 1,000/- value of the above items in the form of Demand Draft/Pay Order from any Nationalized Bank in favour of “**Accounts Officer, Films Division, Mumbai**”. The bid which is not accompanied by the Earnest Money Deposit will not be considered and will be rejected.
3. The scrap material is for sale on “AS IS, WHERE IS BASIS”. No claim shall be entertained on any account quality/condition of the materials what so ever, once the bid is submitted by the bidder.
4. After issue of letter of acceptance of the offer to the bidder, the bidder will be required to deposit the entire amount along-with the requisite VAT (Finally accepted offer) in advance within 2 days from the date of issue of LOA. The bidder shall be allowed to take out the scrap materials only after depositing the entire amount of the bid material as mentioned above.
5. The successful bidder should lift and take out the entire scrap materials within 2 days from the date of issue of letter of assignment.
6. All the charges towards transportation, loading, unloading, octroi, etc. and any other incidental charges for taking out the scrap materials shall be borne by the bidder. Nothing extra shall be payable by Films Division or its client on this account.
7. Once scrap materials are taken out of the site, it will be the responsibility of the bidder that the scrap material purchased by him is utilized for bonafied purposes as per prevailing law of the country.
8. The Director General , Films Division, Mumbai – 400 026 reserves the right to accept or reject any bids without assigning any reason whatsoever.
