Chapter-I- Instructions to bidder:

- 1. The firms/suppliers interested to supply the requisite material/equipments as mentioned in **Annexure-I** can consult Shri M. Mathialagen, Director (022-23523454) Films Division for clarification/specification, on any working days viz. Monday to Friday from 11.00 am to 5.00 pm(except holidays) in the office of Films Division, Ministry of Information and Broadcasting, Government of India, 24-Dr. GopalraoDeshmukhMarg, Mumbai 400026. The details of this bid notice including specifications of the equipment etc. are available on the official website of Films Division i.e. www.filmsdivision.org
- 2. Possession of valid Digital Signature Certificate (DSC) of the bidders are prerequisite for e-tendering. DSC (applicable to Class-II / Class III with signing key usage) issued by sify /TCS / nCode / eMudra or any others certifying authority recognized by controller of certifying authority (CCA) India on e-Token/ Smartcard are valid to e-Tendering .
- 3. **Technical Bid:** The bid should consist of the following documents:
- i) Profile of the company along with copies of PAN, TIN/TAN and VAT Certificates and authorization certificates of principals.
- ii) Earnest Money Deposit in the specified format
- iii) "Technical Bid" containing detailed technical specifications of the offered product in the specified format (Annexure-1) along with any other brochure, catalogues, documents etc. BUT NOT CONTAINING ANY PRICE INFORMATION ABOUT THE PRODUCTS OFFERED.
- 4. **Financial Bid**:- containing the price schedule (as in the e-tender format) duly filled in with all commercial details of the bid.

All the above documents should be self attested by an authorized signatory of the bidder and should be on the letter head of the bidder and uploaded on the e-tender.

- 5. The bidder except those who are registered with the Central Purchasing Organization, National Small Industries Corporation (NSIC), must enclose with their Technical Bid (e-tender) an Earnest Money (Bid Security) for Rs.50,000/- in the form of either cross Demand Draft, Fixed Deposit Receipt, Banker's Cheque (Pay order) or Bank Guarantee from any of the Commercial Bank drawn in favour of "Accounts Officer, Films Division, Mumbai" valid for a period of 45 days beyond the final bid validity period. The Original DD of the EMD should reach at Director General, Films Division Mumbai before bid opening date of Technical Bid. Only online submission of bid will be eligible for opening. Bids which are not submitted online or where EMD is not submitted before opening of bids will be summarily rejected. The final bid validity period is 90 days.
- 6. The Bidder who are exempted from submission of bid security must produce the Exemption Certificate issued by the concerned authority like NSIC.
- 7. The Earnest Money (Bid Security) may be forfeited by Films Division in the following events:
 - i) If bid is withdrawn during validity period or any extension thereon.
 - ii) If bid is varied or modified in a manner not acceptable to this organization during the validity period or any extension thereof.
 - iii) If a bidder whose bid has been accepted but fails to furnish the performance security deposit, performance bank guarantee within 30 days of acceptance of bid.
- 7. The Earnest Money Deposit(Bid Security) of unsuccessful bidders will be returned on finalisation of bid. The Earnest Money of successful bidder will be returned on receipt of performance security deposit/bank guarantee.
- 8. All leviable taxes/duties, including Sales Tax, Value Added Tax and Service Tax etc., if any may be mentioned separately. If these details are not indicated, it will be assumed that the rate is inclusive of all the taxes excluding Octroi.
- 9. At the first instance the Technical bids will be opened by the Department and the same will be evaluated by the Competent Committee or Authority. Documents like pamphlets, brochure etc. which can not be scanned and submitted online may be given in the envelope in support of Technical Bid. The bidder may be required to arrange a demonstration/presentation of the products offered. At the second stage, Financial bids of only the Technically acceptable offers will be opened for evaluation and ranking before awarding the contract.

10.The successful bidder will furnish a **Performance Security Deposit at the rate of 10% of the value of the total equipment** in the form of Demand Draft/ Pay Order or Fixed Deposit Receipt or Bank guarantee from any commercial Bank drawn in favour of "**Accounts Officer, Films Division, Mumbai**" within 30 days of the receipt of supply order. The Performance Security Deposit will remain with the Films Division, till the warranty period of the equipment is covered.

Chapter-II-Terms and conditions

- 1. The successful bidder will be required to supply and install equipments within one month of the placement of work order.
- 2. There shall be no negotiations in general. Even in exceptional circumstances, negotiations will be carried out only with the lowest evaluated responsive bidder.
- 3. The 50% payment will be made/released after the supply of the equipment. 25% on installation of the equipment and balance 25% on commissioning and successful running of the equipment for about a month. No advance payment will be made under any circumstances. The equipment has to be delivered/installed/commissioned at Mumbai and prices should be inclusive of same.
- 4. Right to accept, reject, split the entire Bid or any part thereof without assigning any reason rests with the Director General, Films Division, Mumbai and his decision in this regard is final and binding.
- 5. Income Tax/Service Tax or any other taxes will be deducted from the bill at source as per Government orders.
- 6. Any disputes arising out of the bid notice, process and finalization of this bid shall be subject to jurisdiction of the High Court of Mumbai.

Chapter-III - Schedules of Requirement:

- 1. The equipment has to be delivered/installed/commissioned at Mumbai and prices should be inclusive of same.
- 2. The successful bidder will be required to supply, install equipments and test within one month of the placement of work order. The 50% payment will be made/released after the supply of the equipment. 25% on installation of the equipment and balance 25% on commissioning and successful running of the equipment for about a month. No advance payment will be made under any circumstances.
- 3. The supplier should offer a minimum warranty period for **three years** for the equipments from the date of its supply.
