The notice is invited on the following terms and conditions:

- 1) The Bidder should get themselves registered with Films Division before auction. Only those agencies shall be allowed to participate in the auction process who have got registered with Films Division before the auction date.
- 2) The scrape material is for sale on “AS IS WHERE IS BASIS” and will be sold on **Kilogram basis** includes outer boxes and tins. No claim shall be entertained on any account regarding quality/condition of the materials what so ever, once the offer of bidder is accepted during the auction.
- 3) On ANNOUNCEMENT for acceptance of the offer of the bidder, the bidder will be required to deposit on the spot an amount of Rs.5,000/- as Earnest Money Deposit by way of Demand Draft/Pay order payable in favour of “**Accounts Officer, Films Division, Mumbai**”. The bidder shall allowed to take out the scrap materials only after depositing the entire amount quoted along with VAT applicable.
- 4) All the interested bidders are hereby advised to remain present themselves on the date and time mentioned above.
- 5) All the bidders will have to register their names with the Films Division, Mumbai by 15/04/2015.
- 6) The Stores being auctioned will be available for inspection of the bidders between 11.00am to 5.00 pm from 06/04/2015 -to 10/04/2015 (excluding Saturday, Sunday &Holidays).
- 7) Highest bidder will have to remove the material at his own cost within 3 days of acceptance of offer & after making full payment. If bidder fails to deposit entire amount as per the auction process within 2 days, then their EMD shall be forfeited.
